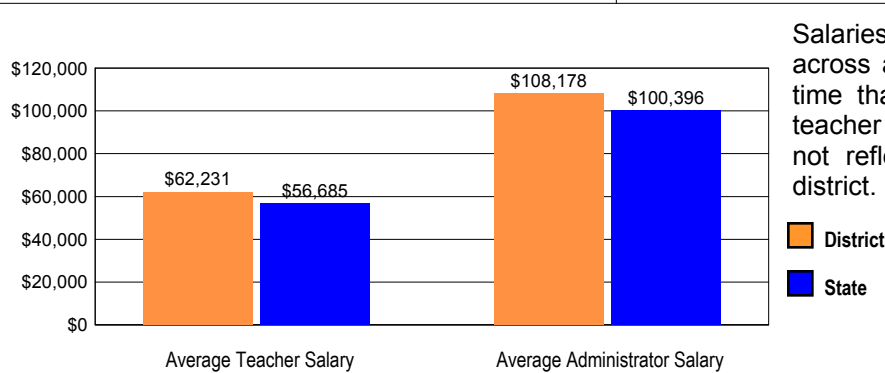

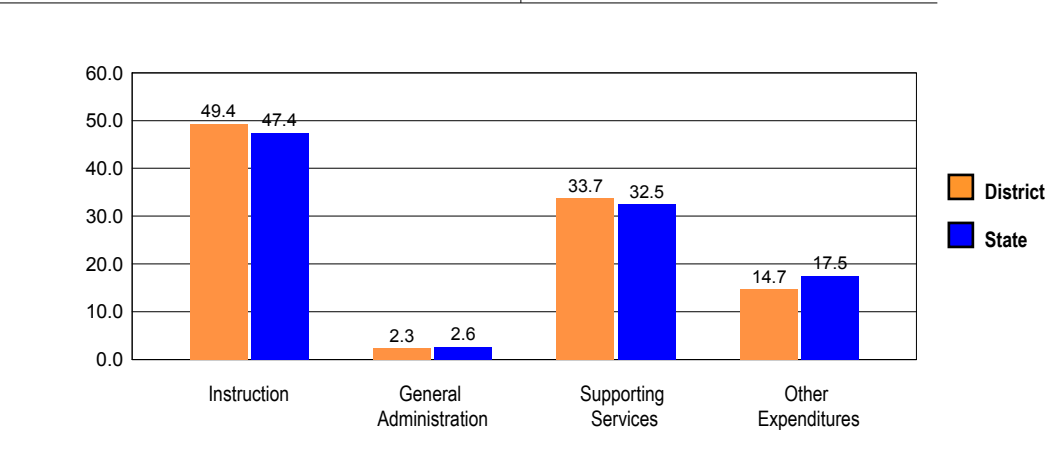
SCHOOL DISTRICT FINANCES

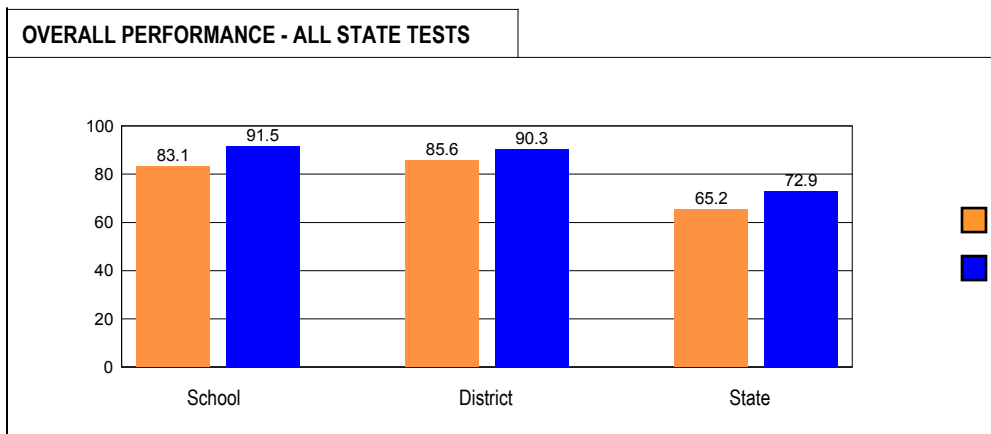

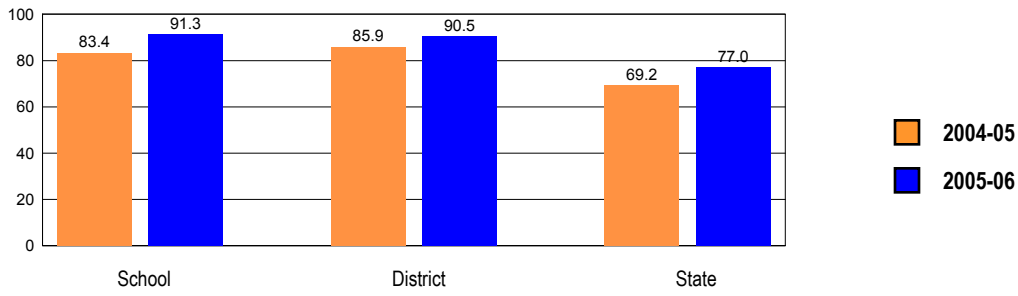
OVERALL STUDENT PERFORMANCE

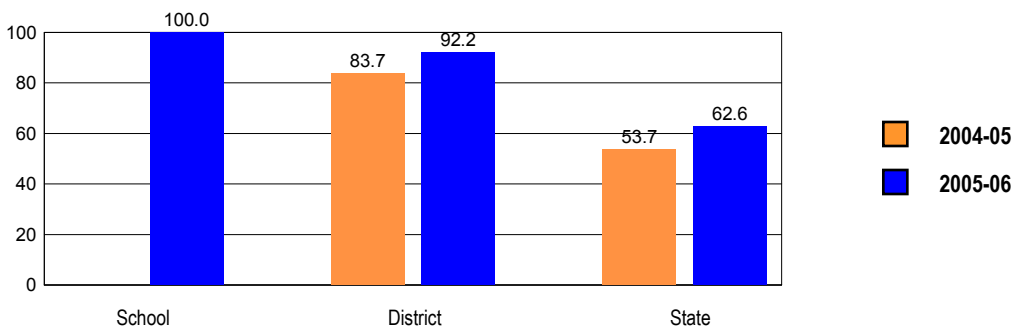

OVERALL ILLINOIS ALTERNATE ASSESSMENT (IAA) PERFORMANCE

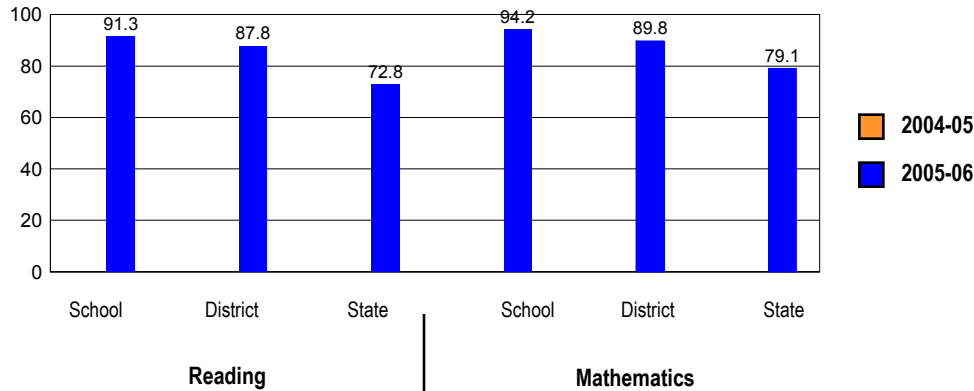


IAA scores in the Progressing and Attaining performance levels count the same, respectfully, as scores on other state assessments that meet or exceed Standards.

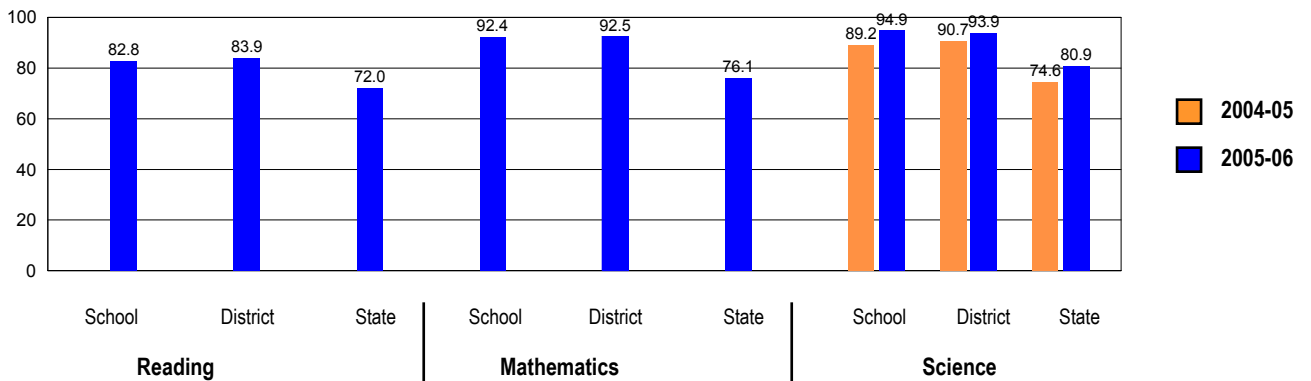
ISAT PERFORMANCE

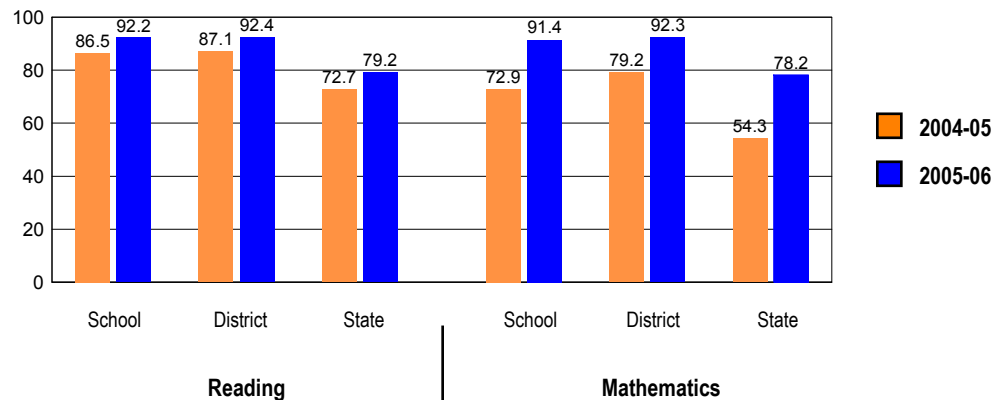
ISAT Grade 6

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Measure of Annual Growth in English (IMAGE) is administered to limited-English-proficient students. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Schools with grade 2 as the highest grade in the school use a state-adopted test in reading and mathematics to meet this requirement.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.

Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.

Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

The four conditions for making Adequate Yearly Progress (AYP) are:

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 47.5% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 47.5% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. ***
3. For schools not making AYP solely because the IEP group fails to have 47.5% meeting/exceeding standards, 14% may be added to this variable in accordance with the federal 2% flexibility provision.
4. At least 89% attendance rate for non-high schools and at least 69% graduation rate for high schools.

**Orland Junior High School
2006 School Report Card Narrative**

Orland Junior High School students and staff have focused on two goals during the 2006-2007 school year. The first goal is academic in two parts: to improve reading skills and math skills of targeted students. The second goal is cultural and in three parts: to improve school safety, to improve student behaviors, and to foster a caring, friendly school climate.

To achieve the first goal, students were identified as being "at-risk" using MAP scores and teacher recommendations. Students were placed into SOAR and/or MAGIC classes as deemed necessary to ensure academic success. SOAR (Students of Orland Accelerating Reading) students follow the **READ 180** program. **READ 180** assessments are used to measure success. In January 2007, higher levels of SOAR reading materials were needed to accommodate students who had successfully completed all of the levels of the program. MAGIC (Math Achievement and Growth In Children) students showed gains in classroom performance as measured by the improvement of quarterly grades in mathematics.

The Language Arts curriculum was enriched via a partnership with the local public library and a suburban bookshop to promote reading. Two author visits, as well as a cooperative effort with the Orland Park Public Library, have provided additional resources for teachers to use in the classroom.

To assist students in remediating failing grades, each grade level team runs a substantial *Failure Is Not An Option* program. As soon as students are identified with a failing grade, remediation begins with before school and after school academic assistance, as well as the "Ninth Hour" program. If needed, a Saturday School session is provided.

To achieve the second goal, the PBIS committee delineated and is monitoring progress of the STEPS program of behavior management. This program has allowed the staff to identify the locations, times of day, and types of behaviors that are causing disruptions of the learning process.

With the cooperation of the PFE, recognition programs were continued (i.e. Honor Roll Breakfasts) and new programs were introduced. Those programs include Friday popcorn rewards for classes nominated by the teacher, Four Stars Weekly Reward drawings, and a Quarterly Reward Assembly or other activity for students who exhibited exemplary behavior.

Staff surveys were completed in August and in February to assess the impact of new building policies and procedures. Analysis of the survey results shows an improvement in consistency of discipline, an improvement in educational leadership, and an improvement in interpersonal relationships.
